

ORDINANCE NO. 2006-008

**AN ORDINANCE OF THE VILLAGE OF WIMBERLEY, TEXAS
DISSOLVING THE WIMBERLEY ECONOMIC DEVELOPMENT
ADVISORY BOARD AND REPEALING ORDINANCE NO. 2003-02; AND
PROVIDING FOR THE FOLLOWING: FINDINGS OF FACT;
REPEALER; SEVERABILITY; EFFECTIVE DATE; AND PROPER
NOTICE AND MEETING**

WHEREAS, the City Council of the Village of Wimberley seeks to maintain and develop sound economic practices, both passive and active, in its business community within the Wimberley Valley; and

WHEREAS, the City Council previously created an Economic Development Advisory Board ("Board") pursuant to Village of Wimberley Ordinance No. 2003-002; and

WHEREAS, the City Council has determined that the continued operation of the Board is no longer necessary to the achievement of the City's economic development goals;

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE
VILLAGE OF WIMBERLEY, COUNTY OF HAYS, STATE OF TEXAS:**

I. FINDINGS OF FACT

All of the above premises are hereby found to be true and correct legislative and factual findings of the Village of Wimberley and are hereby approved and incorporated into the body of this ordinance as if copied in their entirety.

II. DISSOLUTION OF ECONOMIC DEVELOPMENT ADVISORY BOARD

- A. The Wimberley Economic Development Advisory Board is hereby dissolved.
- B. Village of Wimberley Ordinance No. 2003-002 is hereby and in all things repealed in its entirety.

III. REPEALER

All ordinances or parts of ordinances in force when the provisions of this Ordinance become effective that are inconsistent or in conflict with the terms and provisions contained in this Ordinance are hereby repealed only to the extent of any such conflict.

IV. SEVERABILITY

It is hereby declared to be the intention of the City Council that the phrases, clauses, sentences, paragraphs and sections of this ordinance be severable, and if any phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs or sections of this ordinance, and the remainder of this Ordinance shall be enforced as written.

V. EFFECTIVE DATE

This Ordinance shall take effect immediately upon its passage and publication as may be required by governing law.


VI. PROPER NOTICE AND MEETING




