MOBILE FOOD ESTABLISHMENT REQUIREMENTS

In order to operate a mobile food establishment in the City limits of Wimberley a permit is required.

The application can be obtained at the City of Wimberley offices located at 221 Stillwater. The cost of the permit is \$75.00 for the first mobile food unit and \$50.00 for each additional mobile food unit. Please be aware that you will need to fill out a separate application for each mobile unit.

Failure to obtain a City permit to sale food in the City limits can result in a fine or other legal action.

REQUISITOS PARA ESTABLECIMIENTO DE ALIMENTOS MÓVIL

Para funcionar un establecimiento móvil de alimentos en los límites de la Ciudad de Wimberley se requiere un permiso.

La aplicación para el permiso puede obtenerse en las oficinas de la ciudad localizada en el 221 Stillwater. El costo del permiso es de \$75.00 por la primera unidad de alimentos móvil y \$50.00 por cada unidad de comida móvil adicional. Se necesitará una aplicación para cada una de las unidades móviles.

La falta de obtener un permiso de la ciudad al alimento de venta en los límites de la ciudad puede dar lugar a una multa o a otra demanda legal.
