Blue Hole Regional Park **Primitive Campground Policies**

Camping is limited to “group camping” only. A “group” consists of no less than 8 campers.

The Primitive Camping area is open year round.

A ratio of 1 adult for every 8 youth campers is required for youth groups.

Tents must remain on the 15'X15' tent pads provided.

No more than 8 people per camp site.

Fee: \$20 per night per campsite for non-profit groups and \$40 per night per campsite for all other groups.

One vehicle is allowed per campsite. A \$5 fee will be charged for each additional vehicle over the limit.

An after-hours access lock will be provided on the front entry gate on nights when the campground is rented.

Water and Restrooms are available at the Recreation Pavilion near the playground. Restrooms do not have shower facilities.

Picnic tables and bbq grills are provided in the adjacent Shaded Picnic Area. No fires are allowed except in the bbq grills provided and no picnic tables or grills are allowed to be brought in.

Pets are prohibited in the Primitive Campground area.

Swimming is prohibited to campers during the offseason. During the season regular swimming charges will apply.

Blue Hole Regional Park is an alcohol and smoke free facility.

All other “General Park Rules” apply while camping.
