4. **MINUTES**
 - 4.1. Consider approval of the November 9, 2022 Transportation Advisory Board Meeting Minutes.

5. **CITY STAFF REPORT**
 - 5.1. Receive an update from Public Works staff regarding road maintenance and projects.

Nathan Glazier reported that he had meeting with city engineer to look at upcoming road projects. Chad will get quotes for:
 - River Road, striping, including double yellow lines with reflectors
 - The horseshoe at the Square: Re-striping parking. The idea is to make them 45-degree angles, which will lose some spaces but allow more space in the

- middle for vehicles to pass one another.
- Blue Heron: Candidate for restriping too.

Nathan Glazier reported the City Council passed the Wimberley Transportation Plan. They did not take the TAB's recommendation to expand standard right-of-way from 60 to 80 feet. The council removed three of the roads on the plan: Projects 14, 19, 20.

6. DISCUSSION AND POSSIBLE ACTION

- 6.1.** Discuss and review board member road assignments and make revisions, if necessary.

A copy of the road assignments was passed out by city staff. Road assignments are for TAB members to check condition of roads and report potholes or other problems to Damien Grimaldi.

Alex Villaret on River Road: If we don't have the money to resurface River Road, I suggest putting hot mix on short stretches, especially from the bridge to Wayside because of the potholes and deterioration of the road. Drainage projects could also be necessary.

- Nathan Glazier said he will add that project to his discussions with the city engineer to get quotes for drainage, mill and overlay.
- Discussion of River Road landowner resistance to improvements. The landowners own the land to the middle of the river, and it's unclear if there's some sort of easement for River Road itself.
- Discussion of whether we might need to get city attorney's opinion on city right or ability to work on River Road.

Tim Patek: The city is going to have a pothole demonstration from a company that makes a pothole-filling machine, which they want to sell to the city. Costs \$80,000

Ben O'Kane: Had a short meeting with Don Montague, constable. Montague asked if anybody has pulled the information from the speed-sign radars?

- Nathan Glazier: Radar Signs, the company, sent us a program and we tried to pull the data off with the program, and it's not working. There is something wrong.
- Tim Patek: We might want to go with a different company if we can't figure out how to pull the information from the signs.
- Aaron Reed says Dripping Springs uses cloud-based radar signs that cost \$2399/sign and \$1800/year subscription. Data can be accessed at any time without downloading it from the sign.
- Montague told O'Kane he will present at next city council meeting on updates on patrolling and pulling over speeders.

- 6.2.** Hold discussion and consider possible action related to low water crossings,

specifically at 1492.

Bob Harla: Harla made outreach to Google and sought advice from TxDOT to try to get the low-water crossing bridge on 1492 labeled on Google Maps as a one-lane bridge that can't handle trucks.

- Nathan Glaiser said he will send an email with city letterhead noting dangerous switchbacks, one-lane bridge, and city ordinance that prohibits truck traffic on 1492. Glazier said he has attempted to edit Google maps through their edit options but has not yet had success.

Discussion of city ordinances and enforcing rules that prohibit trucks traveling through downtown and 1492: The constable and sheriff's office won't enforce city ordinances, according to city staff. There is no interlocal agreement at this point in time. The city's plan to hire a city marshal to enforce traffic laws has been postponed until the next budget. Ben O'Kane suggests trying to get an interlocal agreement with the constable's office to enforce traffic laws.

Signs notifying truckers to stay off 1492: Montague says TxDOT needs to put signs as back as the Junction warning truckers not to turn onto 1492.

- City staff is meeting with Willie Zamora of TxDOT and said they can bring it up.

6.3. Discussion of transportation bonds as a funding mechanism for Wimberley transportation projects. (Board Members Ben O'Kane and Matt Joyce)

Matt Joyce asked if TAB would be interested in studying the idea of proposing a transportation bond to the city council as a way to fund the Transportation Plan's list of projects.

Aaron Reed: First you have to develop Capital Improvement Plan and show exactly what the bond will do. The plan shows a cost allocation for each resident in the city, and here's what the tax burden would be. He said he supports the concept, but Wimberley has never had an ad valorem tax. He's unsure if city council would have the appetite to propose a city bond that would create an ad valorem tax. One challenge would be convincing people to support a tax for road projects that are on the other side of town from their homes.

Matt Joyce asked if a bond might be more successful if it is targeted specifically to sidewalks?

Aaron Reed said he would like to see the city develop a "long-term road maintenance plan" that includes a scoring format to help prioritize road improvement projects.

Ben O'Kane asked about ideas for road maintenance projects to help some other projects we could potentially do to show progress and track record of success? Board members brought up need for fixes to River Road; Kings Way; Buena Vista;

Buena Kings Way; Deer Crossing.

Aaron: Potential for pooling with Dripping Springs.

Bob Harla: Could we look at speed humps again in the future and figure out what might work if we can't find a law enforcement solution?

- Patek: We are also looking at other types of calming measures, such as center stripes.
- Villaret: Stop Signs are another option. The fire department and they seemed more amenable to that.

Aaron: Would it be possible to invite Willie Zamora and Lon Shell to these meetings. Potentially quarterly, not necessarily every month. Potentially Don Montague as well.

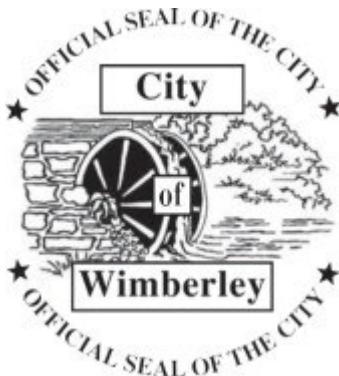
