(A) Construction standards: Dimensions. Any fence that faces a street or road within the incorporated limits of the city and is more than four feet in height: (1) Shall have a solid-to-void ratio no greater than 1:8 (12.5 percent); (2) Shall be no higher than eight feet; (3) Shall be placed only within the street side building setback provided by the zoning district if the building material is chain-link fencing; and (4) Any fence over four feet in height shall require a building permit. (B) Setbacks along streets. Any fence which faces a street or road within the incorporated limits of the city shall be set back from an existing street or road surface on which motor vehicles travel by a distance of not less than six feet or the distance determined by the city to be necessary for the safety of pedestrians and for drainage improvements. (C) that no construction, including site preparation, will commence prior to the issuance of (1) site plan approval; (2) proper zoning approval; and (3) building permit; and (D) agree to comply with all city codes and ordinances pertaining to this project.
