<b>Saturday, January 1, 2022</b>	<ul style="list-style-type: none"> <li>• First day to apply for a ballot by mail</li> </ul>
<b>Wednesday, January 19, 2022</b>	<ul style="list-style-type: none"> <li>• First day candidates may file an application for place on the ballot in the General Election* (Office Hours: Monday – Friday, 8:00 a.m. to 5:00 p.m.)</li> <li>• First day for filing declaration of write-in candidacy</li> <li>• At this time, the appointment of a Campaign Treasurer Form (CTA) may be submitted</li> </ul>
<b>Friday, February 18, 2022</b>	<ul style="list-style-type: none"> <li>• <u>5:00 p.m. deadline</u> – Last day candidates may file an application for place on the ballot in the General Election* (Office Hours: Monday – Friday, 8:00 a.m. to 5:00 p.m.)</li> <li>• Appointment of a Campaign Treasurer Form (CTA) must also be received by <u>5:00 p.m.</u></li> <li>• Last day to order General Election or Special Election on a Measure</li> </ul>
<b>Tuesday, February 22, 2022</b>	<ul style="list-style-type: none"> <li>• Last day to file a declaration of write-in candidacy</li> </ul>
<b>Thursday, April 7, 2022</b>	<ul style="list-style-type: none"> <li>• Last day to register to vote</li> </ul>
<b>Monday, April 25, 2022</b>	<ul style="list-style-type: none"> <li>• First day of early voting by personal appearance</li> </ul>
<b>Tuesday, April 26, 2022</b>	<ul style="list-style-type: none"> <li>• Last day to apply for ballot by mail (<i>received <u>not</u> postmarked</i>)</li> </ul>
<b>Tuesday, May 3, 2022</b>	<ul style="list-style-type: none"> <li>• Last day of early voting by personal appearance</li> </ul>
<b>Saturday, May 7, 2022</b>	<ul style="list-style-type: none"> <li>• <b>ELECTION DAY (Polls open from 7:00 a.m. to 7:00 p.m.)</b></li> <li>• Last day to receive ballot by mail, at 7:00 p.m., if carrier envelope is not postmarked</li> <li>• Unofficial Tabulation of Results</li> </ul>
