**ORDER NO. 2
MEMORIALIZING JUNE 1, 2015 PREHEARING CONFERENCE,
SCHEDULING SECOND PREHEARING CONFERENCE, AND
SCHEDULING HEARING ON THE MERITS**

On June 1, 2015, the Administrative Law Judge (ALJ) convened the first prehearing conference in the above-referenced docket. The City of Wimberley, the Executive Director of the Texas Commission on Environmental Quality (ED), and the Office of Public Utility Council appeared at the prehearing conference.

The ALJ admitted in evidence ED exhibits A, B, and C to establish jurisdiction and proper and adequate notice of the application. No party objected to jurisdiction or notice.

The ALJ named Blanco River Cypress Creek Water Association as a party, and it can participate in all aspects of the proceeding. Aqua Utilities, Inc. d/b/a Aqua Texas moved for party status. Several parties objected to Aqua Texas' request for party status, and the ALJ withheld a ruling until the parties had time to address the issue in written pleadings. Aqua Texas shall remain on the service list for now, pending a ruling on its party status. Aqua Texas and any other entity or individual shall file its request for party status no later than June 17, 2015, and any replies to party status shall be filed by noon on June 23, 2015.

The second prehearing conference will begin at 10:00 a.m., Wednesday, June 24, 2015, at the State Office of Administrative Hearings, 300 West 15th, William P. Clements Building, Fourth Floor, Austin, Texas. At this prehearing conference, the ALJ will consider party status of



Aqua Texas and other entities/individuals, address any pending motions, set other procedural deadlines, and consider any other issues relevant to this proceeding.

The ALJ scheduled the hearing on the merits for January 25-29, 2016. After naming all parties, the ALJ will determine the location of the hearing. Discovery in this proceeding begins June 1, 2015. Other procedural deadlines will be determined at the June 24, 2015 prehearing conference.
