

RESOLUTION NO. R-048-2003

RESOLUTION CANVASSING ELECTION RETURNS AND DECLARING RESULTS OF ELECTION HELD ON MAY 3, 2003 TO ELECT A MAYOR AND THREE MEMBERS OF THE VILLAGE OF WIMBERLEY CITY COUNCIL, FOR THE VILLAGE OF WIMBERLEY, HAYS COUNTY, TEXAS.
