

RESOLUTION NO. R-63-2003

A RESOLUTION OF THE VILLAGE OF WIMBERLEY, TEXAS APPOINTING MEMBERS TO THE PLANNING AND ZONING COMMISSION; PROVIDING FOR PLACES AND TERMS OF OFFICE.

WHEREAS, the Village of Wimberley established a place system and two (2) year terms for members of the Planning and Zoning Commission ("Commission") in Ordinance No. 2003-007; and

WHEREAS, Ordinance No. 2003-007 provides for appointment of seven members to the Planning and Zoning Commission; and

WHEREAS, Planning and Zoning Commissioners ("Commissioners") assigned places one (1), three (3), five (5) and seven (7) shall serve a term commencing on the effective date of this Resolution and ending November 1, 2004 and Commissioners assigned places two (2) four (4), and six (6) shall serve a term commencing on the effective date of this Resolution and ending November 1, 2003.

NOW THEREFORE, be it resolved by the City Council of the Village of Wimberley, County of Hays, State of Texas:

I. APPOINTMENT OF MEMBERS

The following named individuals shall serve as members of the Planning and Zoning Commission, in the place and for the term as follows:

III. EFFECTIVE DATE


The Resolution shall take effect immediately upon its passage and publication as may be required by governing law.
